The main purpose of this meeting is for the membership to elect the 2019/2020 Board of Directors. As per our bylaws, each Contractor company will have one vote.

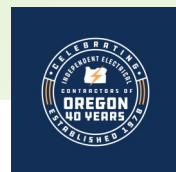
This year, IEC of Oregon will also feature a guest speaker after the business meeting.
